

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF THOUSAND OAKS ESTABLISHING NEW SALARY SCHEDULE FOR THOUSAND OAKS CITY EMPLOYEE ASSOCIATION (TOCEA) AND RESCINDING RESOLUTION NO. 2022-033

WHEREAS, Thousand Oaks City Employee Association (TOCEA) classification salary ranges were previously established by Resolution No. 2022-033 and

WHEREAS, MOU provisions require that classification salary ranges be adjusted to incorporate salary adjustments.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Thousand Oaks as follows:

SECTION 1. This resolution shall rescind and supersede Resolution No. 2022-033 as to TOCEA members.

SECTION 2. The attached Salary Schedule (Exhibit A) be adopted which provides in part:

1. 6.0% Salary Adjustments for all classifications in this unit effective July 8, 2023.
2. Internal salary range adjustments effective July 8, 2023 for the following classifications:
 - Senior Administrative Secretary from range 254 to range 264
 - Environmental Compliance Inspector II from range 294 to range 299
 - Senior Environmental Compliance Inspector from range 309 to range 319
 - Senior Instrumentation and Electrical Technician from range 314 to range 324
 - Senior Recording Secretary from range 264 to range 274
 - Senior Records Management Specialist from range 244 to range 245
 - Utilities Equipment Operator from range 251 to range 261
 - Utilities Maintenance Crew Leader from range 278 to range 291

SECTION 3. The provisions of this Resolution shall become operative and in full force from and after July 8, 2023.

Trainees will be compensated in a salary range equivalent to ten (10) to twenty (20) percent lower than authorized herein at the determination of the Personnel Officer.

* Upon recommendation of the Department Head, and with prior approval of the Human Resources Director, persons hired in an hourly capacity, when assigned lead duties, may earn another \$1.00 - \$2.00/hour for hours worked.
