I am interested in utilizing my professional experiences in the field of conservation and stewardship to serve my community, and to further my professional development goals. I have experience planning and executing conservation projects including acquisitions, restoration, and public access in my time at The Nature Conservancy (TNC) in Ventura County. I have first hand knowledge of funding sources, partnerships, practices, and permitting to complete conservation activities in this project area. I believe these experiences will help me contribute positively to the decision making of the SMMC.

**Briefly describe the experience, skills, or talents you have that you believe will be beneficial to the work of this board or committee. \***

I have worked in the fields of the biological and social sciences and conservation for over a decade. I have published six scientific papers, several in the field of natural resource management and the biological sciences. I have an MS in natural resources and GIS and was a manager for The Nature Conservancy in Ventura County for nearly seven years where I managed over 4,400 acres of conservation lands in Ventura County. I had a diversity of roles and responsibilities as land steward for TNC, including drafting management plans, writing and managing grants, managing public and private partnerships, permitting for restoration and construction projects, planning and managing public access projects, reducing hazards and security risks, managing research projects, initiating volunteer stewardship programs, monitoring properties, and utilizing technology, such as remote sensing, for improved management. In my time at TNC I opened the first publicly accessible preserve to the Santa Clara River in Ventura County--the Santa Clara River Preserve.

In addition to my time with TNC, I was the vice-chair of the Ventura chapter of the Climate Reality Project (2021-2023) as well as a co-founder and steering committee lead of the Conejo Climate Coalition (2021-present). In 2022 I served as a steering committee member for Ventura County's Multi-Jurisdictional Hazard Mitigation Update, and I was a member of cohort 24 of Ventura County Leadership Academy in 2018. Currently I serve as Thousand Oaks representative on the Santa Monica Mountains Conservancy Advisory Committee (2022-present) and an advisory committee member on Ventura Land Trust's advisory committee (2023-present).
