A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF THOUSAND OAKS ADOPTING MITIGATED NEGATIVE DECLARATION FOR THE WASTEWATER INTERCEPTOR CAPITAL IMPROVEMENT PROGRAM UNIT W (CI 5445); AND ADOPTING THE MITIGATION MONITORING PROGRAM

WHEREAS, the City of Thousand Oaks completed a Mitigated Negative Declaration (MND) consistent with the requirements of the California Environmental Quality Act (CEQA) Guidelines; and

WHEREAS, the draft MND was circulated for review, however, no comments on the draft MND were received from the public during the public review period; and

WHEREAS, based on review of the draft MND, final MND, and related materials, as well as staff reports and other information and input received on the environmental documentation prepared for the Project and submitted into public record, City Council finds that the final MND includes the elements required for an MND, and that the final MND informs City Council and the public about potential significant environmental effects of the proposed Project and indicates the manner in which the significant effects can be mitigated or avoided.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Thousand Oaks that:

- 1. The recitals set forth above are incorporated herein as findings of fact by City Council.
- 2. The Final MND has been completed in compliance with CEQA.
- 3. The Final MND has identified all significant environmental effects of the Project and that there are no known potential significant environmental impacts not addressed in the Final MND.
- 4. Although the Final MND identified certain significant environmental effects will result, these significant effects can feasibly be mitigated or avoided and will be reduced to an acceptable level by the imposition of mitigation measures. A Mitigation Monitoring Program has been prepared and incorporated into the Final MND to ensure implementation of the mitigation measures, which the City Council hereby adopts.

- 5. The Final MND was presented to City Council and the City Council reviewed and considered the information contained in the final MND prior to making a determination to approve or deny the Project.
- 6. The Final MND reflects the City's independent judgment and analysis.

BE IT FURTHER RESOLVED that the City Council of the City of Thousand Oaks hereby approves the Final MND for the Wastewater Interceptor Capital Improvement Program Unit W (CI 5445).
