WHEREAS, it is the intention of the Thousand Oaks City Council to consider amendments to the Thousand Oaks Municipal Code to update residential development standards and other zoning regulations to comply with State law and maintain best planning practices; and

WHEREAS, staff has identified certain regulations and standards that warrant review and evaluation, including but not limited to, objective design standards, inclusionary housing ordinance, non-residential linkage fee, and clarification of certain terms; and

WHEREAS, the City Council is directing staff and the Planning Commission to study and make recommendations to the City Council on the above-described amendments; and

WHEREAS, the City Council finds the initiation process for this proposed Municipal Code Amendment is not subject to the California Environmental Quality Act (CEQA) as the activity is not considered a project under CEQA Guidelines Section 15060(c)(3).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Thousand Oaks that this matter is hereby referred to the Planning Commission for a public hearing, report, and recommendation back to the City Council pursuant to Section 9-4.2902 of the Thousand Oaks Municipal Code.
